

DISTRICT OF TAYLOR BYLAW NO. 892, 2024

A Bylaw to Authorize the Charging of Fees and Charges for Various Municipal Services

WHEREAS, Council may impose fees with respect to all or part of a service of the municipality, the use of municipal property, or the exercise of authority to regulate, prohibit or impose requirements,

AND WHEREAS, District of Taylor Consolidated Fees and Charges Bylaw No. 866, 2023 authorizes the levying of various fees,

AND WHEREAS, it is desired that certain fees be amended,

NOW THEREFORE, the Council of the District of Taylor in open meeting assembled hereby enacts as follows:

1. TITLE

1.1 This bylaw may be cited as "Consolidated Fees and Charges Amendment Bylaw No. 892, 2024".

2. FEES AND CHARGES

2.1 Schedules "A" through "H" in Consolidated Fees and Charges Bylaw No. 866, 2023 and in all subsequent amendments up to this bylaw be amended and replaced by the Schedules "A" through "H" attached to and forming part of this bylaw.

3. SEVERABILITY

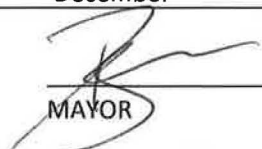
3.1 If any section, subsection, sentence, clause or phrase of this bylaw is, for any reason, held to be invalid by the decision of any court of competent jurisdiction, the invalid portion shall be severed and the decision that it is invalid shall not affect the validity of the remainder of this bylaw.

4. EFFECTIVE DATE

4.1 This bylaw shall come into force and takes effect on January 1, 2025.

Required amount of contribution to care funds:

As per section 20 of the Cremation, Interment and Funeral Services Regulation:

- 1 Right of Interments, excluding those for the Columbarium, require a care fund deposit of not less than 25% of the selling price.
- 2 Right of Interments, for the Columbarium only, require a care fund deposit of not less than 10% of the selling price.
- 3 Memorial installations require a carefund deposit of not less than \$10 for each memorial installed at the place of interment.
